All that lot of land in the City and County of Greenville, State of South Carolina known as the eastern portion of lot 22, Section B of property of Stone Land Company as shown on plat recorded in Plat Book A at P ge 341, in the H.M.C.Office for Greenville County, plus an eight foot addition at the rear as hereinafter explained, and having the following metes and bounds, to-wit:

Beginning at a stake on the north side of Croft St., a distance of 217 ft. and 6 inches east of the northeast corner of Croft and Robinson St. and as the joint corner of lots 22 and 24, and running thence along the joint line of said lots, N 1-41 E, 208 ft. to a stake in the approximate center of former alley; thence S 1-41 7, 208 ft. to a stake on Croft St.; thence along Croft St., S 83-13 E,54 feet to the beginning corner. Being the same lot conveyed to F.D.Bailey by deed book 391 at page129. By agreement of all abutting land owners, the 16 foot alley originally at the rear of said lot was closed so that all abutting property owners on said alley acquired 8 feet additional in the depth of said lots, which were originally 200 feet in depth. This agreement was dated April 8,1924, signed by C.C.Wyche, et al., recorded in Deed Book 100, page 204. By agreement with the adjoining landowner to the west, a concrete wall was built running from the croft street sidewalk to a distance of about 100 feet toward the rear. This wall is a line wall by agreement of the parties. By this is meant that it is on the line Being the same property conveyed me in deed book 391, page 129.

The grantee assumes that note and mortgage to First Fed.Savings & Loan Assn. in the sum of \$7,280.89 recorded in mortg ge book 556 at page 284.


