

BEGINNING at an iron pin on Settlement Road and running thence S. 19-30 E 977.5 feet to a stone; thence S. 57-30 E. 463 feet to a stone; thence S. 6-45 E. 528 feet to a dogwood; thence S. 44-00 E. 236.3 feet to a pine; thence S. 24-30 E. 488.4 feet to a stone, lands of C. B. Allen being to the west of said boundary; thence N. 58-00 E. 561 feet to a stone, land of W. H. Bayne being to the south of said boundary; thence N. 3-30 E. 1062.6 feet to a red oak stump, said lands of Fannie Bayne and Homer Allen being to the east of said boundary; thence N. 17-00 W. 500.0 feet to an iron pin; thence N. 65-30 E. 750 feet to appoint in the Old Buncombe Road; thence along said Road N. 33 W. 121.4 feet to a point on the northern side of said Old Buncombe Road; thence along said Road N. 70-30 W. 363 feet to a bridge over Springg's Creek; thence S. 43-30 W. 132.0 feet to a point in the middle of said Sprigg's Creek; thence S. 0-30 E. 99 feet along said Springg's Creek to a point therein; thence N. 72.1/2 W. 290.4 feet meandering along said Springg's Creek to a stake; thence N. 5-00 W. 278 feet to the center of Settlement Road; thence along said Road S. 83-30 W. 429 feet to a point in the center of Settlement Road; thence continuing along Settlement Road S. 89-30 W. 221.1 feet to a point in said Road; thence continuing along said Settlement Road S. 56-30 W. 106.9 feet to a point in said road; thence continuing along Settlement Road S. 79-30 W. 346.5 feet to a point in said road; thence continuing along said Road S. 78-30 W. 387.4 feet to a point in said road; thence to the beginning corner, an iron pin, several feet away.
