in consideration of the sum of Four Hundred and Eighty Dollars (\$480.00) DOLLARS,

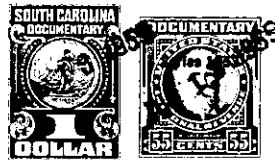
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe H. Ford, his heirs and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and being a portion of the Eastern half of tract No. 31 of Riverside Farms as shown by Plat made by J. H. Foster, Surveyor, August, 1907, and recorded in the R.M.C. Office for Greenville County in Plat Book "K" at Pages 100 and 103, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the North side of a thirty-foot Road, which stake is 50 feet West of the joint corner of Lots Nos. 31 and 32, and running thence in a line parallel with Western line of Lot No. 32, 150 feet to a stake; thence in a line parallel to said thirty-foot road, 50 feet to a stake; thence in a line parallel to the Western line of lot No. 32, 150 feet to a stake on the North side of said thirty-foot road; thence with the North side of said road, 50 feet to the beginning corner.

This is the property conveyed to me by John R. Shackelford by deed dated September 9, 1953 and recorded in the R.M.C. Office for Greenville County in Book 485, Page 264.

The grantor expressly reserves to herself a life estate in this property.
