All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 201, Plat of Augusta Road Branches, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book " ", page 47, and having, according to said plat, the following metes and bounds, to-wit:
