All that piece, parcel or lot of land, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the east side of Mayflower Avenue, being Lot 14 in a Subdivision known as Pecan Terrace as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", page 9, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the east side of Mayflower Avenue at the joint front corner of Lots 13 and 14 and running thence with the joint line of said Lots S. 72-27 E. 150 feet to an iron pin; thence S. 17-33 W. 70 feet to an iron pin corner of Lot 15; thence with the line of that Lot N. 72-27 W. 150 feet to an iron pin on the east side of Mayflower Avenue; thence with said Avenue N. 17-33 E. 70 feet to the beginning corner.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)
