BEGINNING at an iron pin on the south side of East Dorchester Boulevard at the joint front corner of Lots 70 and 71 and running along the joint line of Lots 70 and 71 S. 46-54 E. 150 feet to an iron pin, the joint rear corner of Lots 70 and 71; thence along the line of the subdivision known as Woodfields S. 43-06 W. 173.2 feet to an iron pin in a county road; thence along the line of the county road N. 7-23 W. 179 feet to an iron pin; thence continuing along the curve of the road N. 22-57 E. 43.1 feet; thence along East Dorchester Boulevard N. 55-53 E. 15 feet to an iron pin, the beginning corner.
