KNOW ALL MEN BY THESE PRESENTS that I, E. Allen Harrison in the State aforesaid, in consideration of the sum of Ten and No/100ths (\$10.00) Dollars and other valuable consideration, to the grantor in hand paid at and before the sealing of these presents by the grantee (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto Luther G. Causey, Trustee, his successors and assigns, forever; all of my right, title and interest in and to the following parcels of land:

All that piece, parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina on the North side of the Old Markley Road, joint corner of property of Cross, Fleming and E. W. Davis, being the Northern portion of the tract shown on plat of property of J. A. Mc Cullough, recorded in Plat Book "E", at page 134 and containing 26.4 acres, more or less and described as follows:

BEGINNING at a stone in the center of Old Markley Road, joint corner of properties of Cross, Fleming and E. W. Davis and running thence with said road, North 76-30 W. 207 feet to a point in said road; thence continuing with said road, N. 70-00 W. 121 feet to a point; thence still with said road, S. 77-00 W. 221 feet to a point; thence N. 50-00 W. approximately 1400 feet to a stake; thence N. 42-45 E. 1214 feet to a Chestnut; thence S. 26-00 E. 976 feet to a Chestnut Stump; thence S. 00-45 E. 745 feet to the beginning corner.

ALSO: All that piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina and having the following metes and bounds, to-wit:

- BEGINNING at a stone in the center of a road, joint corner of property of Cross and Fleming and running thence S. 2-15 W. 443 feet to an iron pin; thence N. 46-40 E. 707 feet; thence N. 77 E. 221 feet; thence S. 70 E. 121 feet; thence S. 76-30 E. 207 feet to the beginning corner and containing 3.6 acres, more or less, according to survey made by W. H. Riddle, May 30, 1943.

The road above referred to is a road running up the East side of Paris Mountain known as the Old Markley Road.

ALSO: All that piece, parcel or lot of land in Chick Springs Township, Greenville County on or near Paris Mountain containing 36.9 acres, more or less.

BEGINNING on a sourwood in line of property now or formerly of Boling and Watson and running thence N. 44 W. 726 feet to a stone; thence with property now or formerly of Markley Estate S. 6-26 W. 1725 feet to a stone; thence with property now or formerly owned by Harrell, et al, N. 79-25 E. 780 feet to a stone in line of property conveyed to Marsmen, Inc. by deed recorded in Deed Book 163, page 317, RMC Office for Greenville County; thence with line of Marsmen, Inc. property as follows: N. 13-20 W. 122 feet; thence along a branch N. 72-10 E. 845 feet; thence N. 26-30 E. 570 feet to a stone; thence along Marsmen, Inc. property N. 78-50 W. 1144 feet to the beginning corner.
