ALSO: All that lot or parcel of land situate, on the East and Southeast side of Dld Road leading to the Markley property on Paris Mountain in Paris Mt. Township in Greenville County and being shown as a portion of Section A on plat of property of Paris Mt. Ceasar's Head Co. property made by Pickell & Pickell, May, 1950.

TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the grantee hereinabove named and his successors and assigns, forever.

And the grantor coes hereby bind the grantor and the grantor's heirs, executors, and administrators to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and the grantee's successors and assigns against the grantor and the grantor's heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
