- (a) That written notice of such mortgage or mortgages be given to Tenant within ten days after the recording thereof.
- (b) That the aggregate of the principal installment payments, if any, and interest, and any other sums required to be gaid under or expended because of any such mortgage or mortgages, shall not exceed for any year the share of the fixed rent which the mortgaging Landlord or Landlords are entitled to receive as their pertlem of the said fixed rent under the terms of this lease for any such mortgage or mortgages, taxes and any other items which Tanant to obligated to pay under the terms of this lease shall not be included.
- (c) That if said Landlord or Landlords shall default in the payment of such principal installment payments, 12 any, and installment of any such mortgage or mortgages, the Tenant shall have the right to pay the same by applying the net rentals (fixed or percentage) due and payable to said Landlord or Landlords to said payment as long as such default shall exist. Upon such default by said Landlord or Landlords, Tenant shall have the right to withhold the said fixed rents in order to accumulate a fund sufficient to pay any such past-due mortgage principal or interest, and Tenant shall also have the right to pay any such past due mortgage principal, interest or other charges and take credit for the same as against any rento (fixed or percentage) thereafter becoming due to such mortgaging Landlord or Landlords, and in such case, to the extent of any such prepayment of rent, Tenant shall be entitled to interest from the date of such prepayment to the date the same would otherwise be payable to said Landlord or Landlords at the rate of six per cent (C)) per annum.
- (d) Such Landlord or Landlords shall precure from the mortgages an agreement with the Tenant agreeing that such mortgages will not institute any foreclosure or execution proceedings under the said mortgage or any other proceedings which might interfere with Tenant's quiet use and possession of the demised premises without first giving the Tenant written notice of such contemplated action and without allowing Tenant a period of twenty days thereafter to remedy any defaults.
- (e) That a copy of the mortgage, certified to be true and correct by the mortgagee, be delivered to Tenant within ten days after the recording of same.

Ene Tenant agrees to execute and deliver to any one or more of cald Landlord upon demand, at no expense to said Landlord or Landlords, such further instruments, properly executed and in secondable form, which may to necessary and/or desirable by said Landlord or Landlords to further effect such subordination of this lease to the land mortgage loan, provided that nothing therein contained shall be contrary or inconsistent with the providence of this lease.

It is further understood and agreed that the above proviolence for subordination shall apply only in the event that the Namidated or fundicade desire to subject and subordinate this leads to the lasm of any new mortgage or mortgages. Any one or more of
