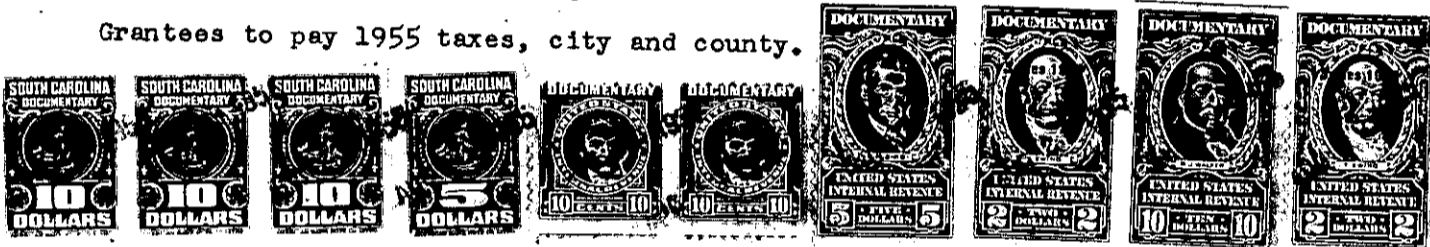

ALL that certain piece, parcel or lot of land with improvements thereon located in Greenville Township, Greenville County, South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 2 of the property of Central Development Corporation according to a plat of record in the R.M.C. Office for Greenville County in Plat Book "BB", at Pages 22-23, and having the following metes and bounds, to-wit:

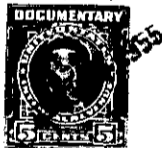
