That I, Donald E. Baltz in the State aforesaid, in consideration of the sum of Eleven Thousand One Hundred (\$11,100.00) DOLLARS,

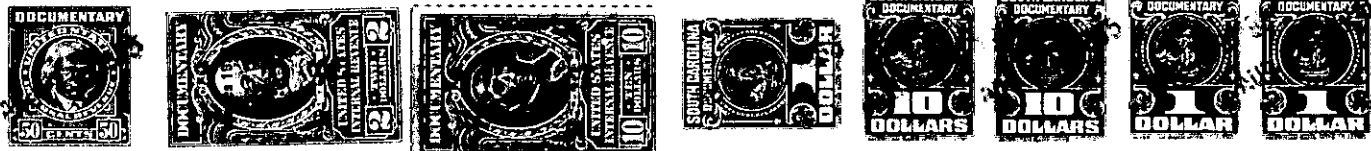
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe Harper Burdette,

All that lot of land near the city of Greenville, in the county of Greenville, state of South Carolina, being known and designated as Lot No. 10, on plat of Donald E. Baltz, recorded in plat book BB page 175, Office of R.M.C., Greenville County, S. C., and having according to a recent survey made by R. W. Dalton, August 1955, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwestern side of Myron Lane, the front joint corner of Lots Nos. 10 and 11, and running thence with the joint line of said lots S. 30-01 W. 110 feet to an iron pin; thence N. 59-59 W. 75 feet to an iron pin corner of Lot No. 9; thence with the line of said lot N. 30-01 E. 110 feet to an iron pin on the southwestern side of Myron Lane; thence with the southwestern side of said Street S. 59-59 E. 75 feet to the beginning corner.

This being a portion of the same property conveyed to grantor by W. W. Wilkins by deed dated December 31, 1954 recorded in volume 515 page 155 of the R.M.C. Office for Greenville County.

This conveyance is made subject to the building restrictions recorded in deed book 516 page 17 and to recorded easements.
