to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CHARLES MONOS and IRENE S. MONOS, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Nottingham Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 201 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", pages 70 and 71 (also recorded in Plat Book "GG", pages 2 and 3), and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Nottingham Road at joint front corner of Lots 200 and 201, and running thence with the line of Lot 200, S. 20-17 E., 160 feet to an iron pin; thence S. 69-43 W., 75 feet to an iron pin; thence with the line of Lot 202, N. 20-17 W., 160 feet to an iron pin on the Southeast side of Nottingham Road; thence along the Southeast side of Nottingham Road, N. 69-43 E., 75 feet to the beginning corner.

This is a portion of that property conveyed to the Grantor and John T. Douglas by deed of The First National Bank of Greenville, S. C., as Substituted Trustee under the will of J. Sproull Marshall, deceased, dated March 1, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 430, page 155; subsequently John T. Douglas conveyed his one-half interest in the above lot to the Grantor herein, L. A. Moseley, by deed dated March 30, 1955, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 526, page 59.

This property is conveyed subject to restrictions recorded in Deed Book 492, page 221, R.M.C. Office for Greenville County, S. C.

GRANTEE to pay 1955 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
