

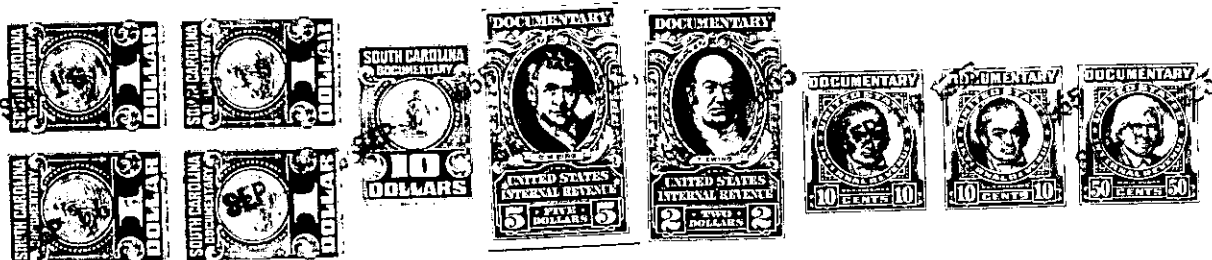
STATE OF SOUTH CAROLINA, GREENVILLE COUNTY

Harvey in the State aforesaid, in consideration of the sum of Six Thousand Eight Hundred & 00/100-----(\$6,800.00)----- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. B. Harvey and Annie Lou Harvey, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, located on U. S. Highway No. 29 and having the following metes and bounds as shown on plat of property of T. G. Harvey made by J. C. Hill, Engineer, dated April 2, 1952.

BEGINNING at an iron pin on U. S. Highway No. 29 at joint corner of property belonging to the Grantor herein and running thence along the line of said property N. 73-40 W. 476.9 feet to iron pin on right-of-way of Southern Railway; thence along the right-of-way of said Southern Railway N. 28-45 E. 100 feet to iron pin; thence S. 72-15 E. 457.7 feet to iron pin on U. S. Highway 29; thence running with the line of U. S. Highway No. 29, S. 17-45 W. 84 feet to point of beginning.
