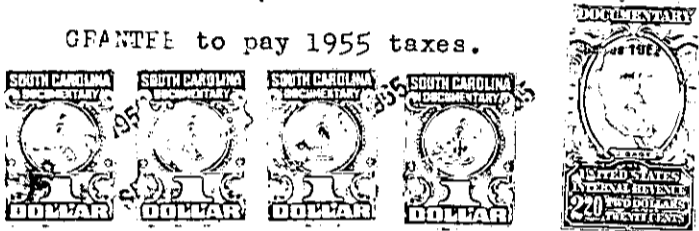
Lindsay J. Forrester, Jr. and Rebekah T. Forrester, Their Heirs and Assigns:
