all that certain piece, parcel or lot of land lying and being in Salton Township, Greenville County, State of South Carolina, lying and being on the N/S of the Tilley bridge road, on the E/S of an unnamed road leading to Hall property with the following general description:

BEGINNING at the joint corners of this property and property of "Snake" Hall on the N/S of the unnamed road mentioned above and running in a general NE direction along the line of property of Snake Hall and Connor; thence in a line at right angle to the aforementioned line; thence in a general SW direction to the aforementioned road; thence with the said road to the beginning corner and containing 6 acres, more or less.

This property is more accurately described in a plat of survey made by J.P. Morrow, L.S., recorded in the REC Office of Greenville County:
