BEGINNING at an iron pin on the west side of Kelley Avenue at joint front corner of Lots Nos 1 and 2 and running thence with the line of Lot No. 2 N. 78-31 U, 115.2 feet to an iron pin; thence S. 10-25 W, 41.8 feet to an iron pin on the North side of a 30 foot street; thence along the North side of said 30 foot Street, S. 81-10 E, 114.5 feet to an iron pin at the Northwest corner of intersection of Kelly Avenue and 30 foot street; thence along the West side of Kelly Avenue, N. 8-55 E, 36.9 feet to the beginning corner.

The Grantor reserves to himself, his heirs and assigns the right to maintain a water pipe line and a sever line across the rear portion of the above lot, together with the right to enter upon said premises for the purpose of repairing or replacing either of said lines.
