



Know All Men by These Presents:

That we, J. Dewey Oxner and W. W. Wilkins, in the State aforesaid, in consideration of the sum of --Three Hundred Seventy-five (\$375.00)-- DOLLARS, and exchange of property valued at Nine Hundred (\$900.00) Dollars to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Harold H. Martin, his heirs and assigns:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Seventeen (17) on plat of Carver Court made by Piedmont Engineering Service, March, 1955, and recorded in the R.M.C. Office for Greenville County in Plat Book I I, page 107, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on the south side of Elder Street, 1/4 block west corner of Lots 18 and 17 and running thence along the line of Lot No. 18 S. 37-02 E. 155.8 feet to an iron pin; thence S. 52-31 W. 37 feet to an iron pin corner of Lot No. 18; thence along the line of Lot No. 18 N. 43-40 W. 144.7 feet to an iron pin on Elder Street; thence along Elder Street N. 38-02 E. 45 feet to an iron pin; thence continuing along Elder Street N. 52-38 E. 31 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 525, page 237, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, dated September 1, 1955, and not yet recorded.

The lot herein conveyed constitutes a portion of the property conveyed to Mrs. Jessie D. Webster by deed dated September 28, 1954, and recorded in the R.M.C. Office for Greenville County in Deed Book 509, page 122.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
