Cleveland, her heirs and assigns forever.

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, being known and designated as the greater portion of Lot No. 37, Block B, of the Stone Land Company property as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book A, at pages 336-343, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Randall Street at the joint front corner of Lots Nos. 35 and 37, Block B, which pin is 393 feet easterly from the southeast corner of the intersection of Randall Street and Wilton Street, and running thence along the south side of Randall Street, S. 83-13 E. 98.25 feet to an iron pin; thence on a line through Lot No. 37, Block B, S. 1-41 W. 208 feet to an iron pin in the middle of an alley; thence along the middle of said alley, N. 83-13 W. 98.25 feet to an iron pin at the rear corner of Lot No. 35, Block B; thence along the line of that lot, N. 1-41 E. 208 feet to an iron pin, the point of beginning.

The above description includes all of our right in the alley in the rear of said lot.
