Ferris E. Reynolds, his heirs and assigns forever:

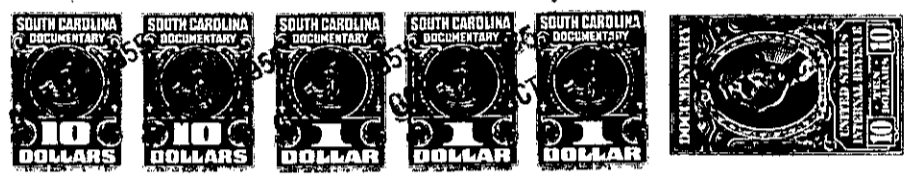

BEGINNING at an iron pin on the southeasterly side of Crosby Circle, joint front corner of Lots Nos. 70 and 71, and running thence along the common line of said Lots S 47-47 E 168.1 feet to an iron pin in creek; thence along the creek as the line, the traverse line being S 63-20 W 70 feet to an iron pin; thence continuing along said creek S 54-45 W 16.9 feet to an iron pin, joint rear corner of Lots Nos. 71 and 72; thence along the common line of said Lots N 43-15 W 145.3 feet to an iron pin on the southeasterly side of Crosby Circle; thence along the southeasterly side of Crosby Circle N 46-45 E 70 feet to an iron pin, the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

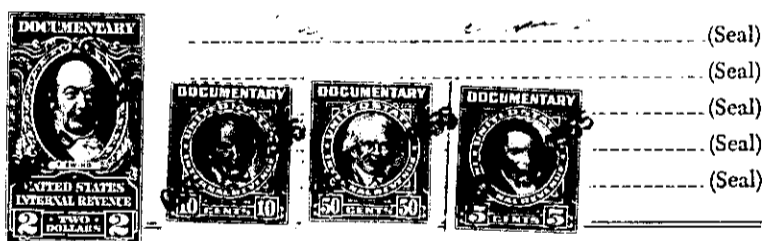
