Know All Men by These Presents:

That I. E. B. Willis, Jr.

in consideration of the sum of Ten Thousand Two Hundred and no/1 (\$10,200.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gordon Earl Powell, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the westerly side of Bent Twig Drive, near the City of Greenville, S. C., and being shown as Lot No. 2 on the plat of Biltmore as recorded in the REC. Office for Greenville County, S. C. in Plat Book "Y", page 147, and having according to said plat the following meter and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Bent Twig Drive at a point 25 feet north of the northwesterly corner of the intersection of Bent Twig Drive and Two Notch Road, said pin being the joint front corner of Lots Nos. 2 and 3, and running thence along the westerly side of said Drive N 14-46 E 75 feet to an iron pin, joint front corner of Lots Nos. 2 and 3; thence along the joint line of said Lots N 75-14 W 151.6 feet to an iron pin; thence N 14-46 E 75 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence along the joint line of said Lots S 75-14 E 151.6 feet to the point of beginning.
