to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. M. Paul, Jr., and E. M. Lineberger, their heirs and assigns forever,

All that piece, parcel or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 120 on plat of University Park by Dalton & Neve's dated November, 1946, recorded in the R.M.C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Brookside Circle at the joint front corner of Lots Nos. 119 and 120, and running thence with the joint line of said lots south 37-34 east 170.4 feet to an iron pin; thence along the rear line of Lot No. 94 north 52-26 east 75 feet to an iron joint rear corner of Lots Nos. 120 and 121; with the joint line of said lots north 37-34 west 158.2 feet to an iron pin on the southern side of Brookside Circle; thence with Brookside Circle wouth 61-46 west 76.2 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R.M.C. Office for Greenville County in Volume 345 at page 159.
