All that piece, parcel or lot of land situate, lying and being at the North-eastern corner of Parker Road and Thomas Street near Monaghan Mills in the County of Greenville, State of South Carolina, and known and designated as Lot No. 18 as shown on a plat entitled "Monaghan Subdivision, Greenville, S. C." made by Piedmont Engineering Service, Greenville, S. C., August 9, 1954, and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Parker Road at the joint front corner of Lots 17 and 18 and running thence with the Northeastern side of Parker Road N. 51-30 W. 105 feet to an iron pin; thence along a curved line, the chord of which is N. 5-20 W. 34.6 feet to an iron pin on the South-eastern side of Thomas Street; thence with the Southeastern side of Thomas Street N. 40-51 E. 60 feet to an iron pin; thence continuing with the South-eastern side of Thomas Street N. 45-49 E. 72.9 feet to an iron pin at the joint corner of Lots 18 and 19; thence with the common line of said two lots S. 45-36 E. 118.1 feet to an iron pin at the joint rear corner of Lots 17 and 18; thence with the common line of said two lots S. 38-30 W. 145.2 feet to an iron pin, the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R. M. C. Office for Greenville County in Deed Book 509, at page 443, and to an easement for utilities service dated October 11, 1954, given by J. P. Stevens & Co., Inc. to Duke Power Company and recorded in the R. M. C. Office for Greenville County in Deed Book 510 at page 317.
