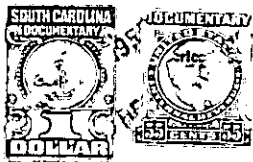

Wilson and Rexford Allen Wilson, their heirs and assigns, forever:

All that piece, parcel or lot of land in the State and County aforesaid, being designated as Lot No. 226 in the subdivision known as Pine Forest and having, according to Plat No. 2 of the Conestee by Madison H. Woodward, R. E., recorded in the R. M. C. Office for Greenville County, in Plat Book "T" pages 383-384, the following courses and distances:

BEGINNING at an iron pin on the northeastern side of Pine Lake Circle at the joint front corner of lot Nos. 226 and 227 and running thence with the joint line of said lots N. 39-35 E. 177.5 feet to an iron pin; thence S. 48-30 E. 60.1 feet to an iron pin at the front rear corner of lot Nos. 225 and 226; thence with the joint line of said lots S. 39-35 W. 175.8 feet to an iron pin on Pine Lake Circle; thence with Pine Lake Circle, N. 48-50 W. 60 feet to the beginning corner.

This conveyance is subject to all restrictions, building covenants, easements and rights of way of record.
