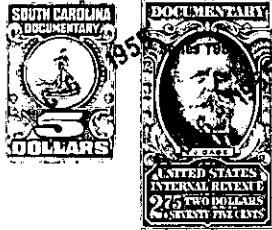
That I, Wade H. Greene, Jr.

An undivided one-half interest in and to the following described property to-wit:

ALL those two lots of land in Greenville Township, Greenville County, State of South Carolina, on the Northeast side of the Laurens Road and being shown as Lots Nos. 20 and 21, on plat of property of Lullwater Syndicate, Inc. made December 1940 by Dalton & Neves, said Plat being recorded in Plat Book K, Page 134, said lots being more particularly described as follows:

BEGINNING at an iron pin on the Laurens Road, joint front corner of Lots Nos. 19 and 20 and running thence N. 16-53 E. 119.5 feet to an iron pin on a 15 foot alley; thence along said alley S. 72-30 E. 154.1 feet to an iron pin; thence S. 32-17 W. 127.8 feet to an iron pin on Laurens Road; thence N. 69-23 W. 120.4 feet along Laurens Road to the beginning corner.
