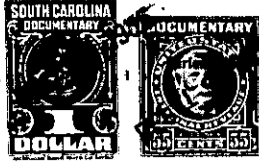

**Harold M. Waldrop, Jr. his heirs and assigns, forever:**

All that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 83A, Section 2, Bellwood Estates on Plat by Woodward Engineering Company now being recorded, and having, according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the Western side of Sunnydale Drive at the joint front corner of lots Nos. 83A and 84A and running thence with the joint line of said lots N. 89-34 W. to a point in the center of a creek; thence with the creek as the line, the traverse course and distance of which is N. 13-46 E. 80 feet, to the joint rear corner of lot Nos. 83A and 82A; thence with the joint line of said lots S. 89-34 E. 153.6 feet to an iron pin on Sunnydale Drive; thence with Sunnydale Drive S. 3 E. 79.4 feet to the beginning corner.

Granteee to pay the 1955 taxes.

This conveyance is subject to all easements and rightsofway of record and to the following restrictions, covenants and conditions:

That the said lands shall not be sold, rented or otherwise disposed of to any Negro or African descent. No residence shall be built on any lot costing less than Seven Thousand and Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lot nearer than twenty-five (25') feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks. This property sold subject to rightsofways to Duke Power Co., granted or to be granted, for residence power line.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
