All that lot of land in Saluda Township, Greenville County, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at a stake in the center of Road leading from Buncombe Road to Cleveland, at corner of property owned jointly by J. Harvey Cleveland and T. C. Gower; thence along road, S. 83-30 E. 200 feet to an angle; thence continuing with road, S. 70-45 E. 340 feet to a stake in road; thence with line of property of C. O. Goodwin, N. 11-0 W.
