## CHARTER.

BY THE SECRETARY OF STATE

. 19 40, file with the Secretary of State a written Declaration,

signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is

EROWN FINANCE COMPANY, INC.

THIRD: That the principal place of business is

LAKE CITY, S.C.

FOURTH: That the general nature of the business which it is proposed to do is to engage in borrowing and lending money, discounting notes, mortgages, bonds and other securities, writing all kinds of automobile insurance, buying, owning, repairing and selling automobiles of every kind and description, automobile parts and accessories thereto, gasoline and oil; buying, owning, selling and renting real estate; to act in the fiduciary capacity as administrator, executor or trustee; to buy, own and sell stocks and bomis, and the doing of all things necessary or incident to the above businesses.
