FOURTH: That the general nature of the business which it is proposed to do is

To produce, prepare, manufacture, compound, mix, use, extract, combine, treat, experiment with, buy or otherwise acquire, sell, deliver, distribute, import, export, lease, trade, mortgage, deal in and otherwise dispose of chemicals, solid, liquid and otherwise, chemical and synthesized products of every nature and description, organic and inorganic, crude and refined, now or hereafter known or discovered, and compounds, intermediates, derivatives and by-products thereof and products to be made therefrom and all other articles and things pertaining to chemistry or to the general chemical business, or containing or requiring in the making thereof the use or application of any chemical or requiring in the making thereof the use or application of any chemical or chemicals whatsoever, including specifically, but without limiting the generality of the foregoing any and all forms of ammonia, nitrogen, phosphates, alkalis, alcohols, fertilizers, explosives and similar and dissimilar substances, compounds, synthetics and products of every description, solids, gases, liquids, metals, carbons, solutions, solvents and synthetic substances, and every chemical or mechanical combination, by-product and product and derivative of any of the matters, substances, things and products mentioned in this paragraph.

To have one or more offices, to carry on all or any of its operations and business and without restriction or limit as to amount to purchase or otherwise acquire, hold, own, mortgage, sell, convey, or otherwise dispose of real and personal property of every class and description in South Carolina and any of the states, districts, territories or colonies of the United States, and in any and all foreign countries, subject to the laws of such state, district, territory, colony or country. trict, territory, colony or country.

In general, to carry on any other business in connection with the foregoing, whether manufacturing or otherwise, and to have and exercise all the powers conferred by the laws of South Carolina upon corporations formed under the act hereinafter referred to, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

The objects and purposes specified in the foregoing clauses shall, except where otherwise expressed, be in nowise limited or restricted by reference to, or inference from the terms of any other clause in this Declaration for Charter, but the objects and purposes specified in each of the foregoing clauses of this article shall be regarded as independent objects and purposes.
