

CAMPBELL, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon situate on the North side of Fisher Drive in the City of Greenville, in Greenville County, South Parolina, being shown as a part of Lots 32 and 33, on plat of property of Marsmer, Inc., made by Dalton & Meves, Engineers, June, 1945, recorded in the MIC Office for Greenville County, S. C., in Plat Book "P", page 5, and having according to said plat the following metes and bounds, to wit:

BEGINATIO at an iron pin in the center of Fisher Drive, said point being where the center of Fisher Drive would intersect with the West side of a 20-foot alley If extended in a Southerly direction in a straight line, and running thence to and with the West side of said alley, M. 9-12 M., 250 feet to an iron pin; thence S. 82-48 W., 100 feet to an iron pin; thence with the line of Lot 32, S. 9-12 E., 130 feet to an iron pin; thence S. 80-48 W., 50 feet to an iron pin; thence S. 9-12 E., 120 feet to point in the certer of Fisher Drive; thence along the center of Fisher Drive, N. 80-48 E., 150 feet to the beginning corner.

Tris is the same property conveyed to me by deed of G. D. Eberhardt, dated September 29, 1955, recorded in the RMC Office for Greenville County, S. C., in Deed Boor 540, page 278. Also see deed of G. D. Eberhardt to C. C. Davis, of even date, to be recorded herewith, giving a more complete description of the property conveyed by deed of September 29, 1955.

This property is conveyed subject to a 15-foot easement across the rear portion of Lot 32 for the purpose of ingress and egress. GRANTEE to pay 1956 taxes.




