BEGINNING at an iron pin on the Northern side of Farley Avenue at the joint corner of lots 10 and 11 and running thence with the line of said lots N. 4 W. 93.8 feet to an iron pin, joint corner of lots 11 and 12; thence with the joint line of said lots S. 89-22 E. 150 feet to an iron pin on the Western side of Byron Court; thence with Byron Court S. 0-38 W. 90.4 feet to an iron pin; thence in a curved line around the intersection of Byron Court and Farley Avenue, the arc of which is S. 48-29 W. 33.5 feet to an iron pin on the Northern side of Farley Avenue; thence with Farley Avenue N. 83-40 W. 40.7 feet and N. 77-40 W. 78 feet to the beginning.

The foregoing premises are conveyed subject to restrictions recorded in the RMC Office for Greenville County in Deed Vol. 502 at page 539 and to all other easements and rights of way of record.
