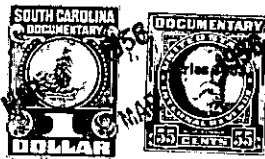

ALL that piece, parcel or lot of land with all improvements thereon, situate, lying and being in Saluda Township, Greenville County, State of South Carolina, being known and designated as Lot No. 54, Section 2A, of a subdivision known as "Lazy City", according to a plat thereof recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 66; reference to said plat is hereby craved for a more particular description.

This is the same property conveyed to the grantor herein by deed of Lazy City, Inc., dated September 23, 1952, recorded in the RMC Office for Greenville County, S. C. in Deed Book 464, page 133.
