Know All Men by These Presents:

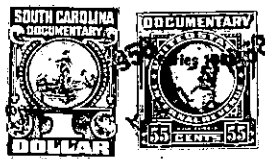

ALL that piece, parcel or lot of land with all improvements thereon, situate, lying and being in Saluda Township, Greenville County, State of South Carolina, being known and designated as Lot Nos. 42 and 43, Section 4, of a subdivision known as "Lazy City" according to a plat thereof recorded in the RMC Office for Greenville County, S. C., in Plat Book "BB", page 69; reference to said plat is hereby craved for a more particular description.
