in consideration of the sum of One Hundred Twenty-two and No/100-----(\$122.00) DOLLARS,

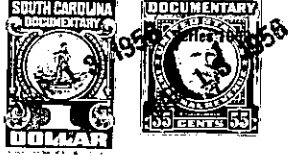
