

in consideration of the sum of One Thousand Nine Hundred Seventy and No/100----- DOLLARS, (\$1,970.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jean H. Knight, Her Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, and being known and designated as Lot Number 50 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Linwood Avenue at the joint front corner of Lots 49 and 50 and running thence N 10-00 W 178.2 feet to a point at the joint rear corner of Lots 49 and 50; thence N 80-30 E 154.6 feet to a point on the Western side of McSwain Drive at the joint corner of Lots 50 and 51; thence with the Western side of McSwain Drive S 20-20 E 62.9 feet to a point; thence continuing with the Western side of McSwain Drive S 15-29 E 107.1 feet to a point; thence following the curvature of the Northwestern intersection of Linwood Avenue with McSwain Drive (the chord of which is S 24-30 W 34.4 feet) to a point; thence with the Northern side of Linwood Avenue S 82-44 W 79.9 feet to a point; thence continuing with the Northern side of Linwood Avenue N 87-10 W 65 feet to a point; thence still continuing with the Northern side of Linwood Avenue S 86-59 W 13.3 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
