in consideration of the sum of Two Hundred Forty Four and No/100 in the State aforesaid, DOLLARS,

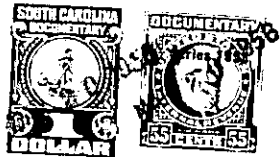
