in consideration of the sum of One Hundred Twenty Two and No/100 - - - - - DOLLARS,

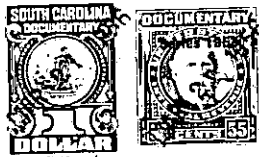
