in consideration of the sum of Seven Thousand Four Hundred Fifty and No/100 - - - - DOLLARS,

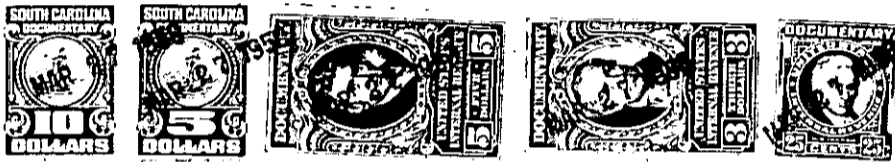
