

C. Jones, C. F., December, 1754 and recorded in the R. M. C. Office for Greenville County in Plat Brok GG, at Page 99, and having, according to said plat, the following metes and bounds, to-wit:

BEGIN ING at an iron pin on the southeast side of Kay Drive at the corner of Lot No. 63, and runring thence along the line of that lot, S. 26-50 E. 160 feet to an iron pin at the rear corner of said lot; thence S. 63-10 W. 106.2 feet to an iron pin or Cement monument on the northeast side of Cool Brook Lane; thence along said Cool Brook Lare, W. 24 -34 W. 135 feet to an iron pin; thence following the curvature of the intersection of Cool Brook Lane and May Drive, the chord of which is N. 19-20 E. 36 feet to an iron pin on the southeast side of May Drive; thence along the southeast side of May Drive, W. 63-10 E. 75 feet to the beginning corner; being the same conveyed to grantor corporation by Local Home Builders, Inc. by deed dated Sentember 13, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 534, at Page 371.

This conveyance is subject to recorded rights-of- ay for the installation and maintenance of public utilities, and to restrictions and protective covenants recorded in the R. M. C. Office for Greenville Coun y in Vol. 513, at Page 535.

It is understood and agreed that as a part of the consideration for this conveyance, the grantee herein assumes and agrees to pay a certain note and mortgage in the original sum of 76,400.00 executed by Local Home Builders, Inc. to First Federal Savings and Loan Association of Greenville, S. C., and recorded in the R. M. C. Office for Greenville County in Mortgage Book 612, at Page 341, on which there is a balance due of 6,277.66.
