That I, L. L. Long in the State aforesaid, in consideration of the sum of Five Hundred Fifty and No/100 - - - - - DOLLARS,

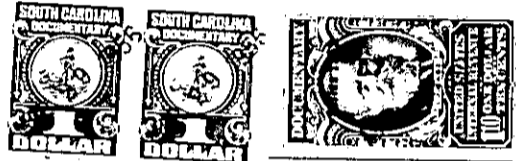
