That Derby Heights Inc. in the State aforesaid, in consideration of the sum of THREE HUNDRED AND NO/100----- DOLLARS,

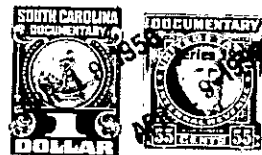

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville being known as Lot No. 190 according to a survey of Belle Meade Subdivision made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book EE, Pages 116-117. Said lot fronts on West Dorchester Boulevard and is more particularly described as follows:

BEGINNING at an iron pin on the west side of West Dorchester Boulevard at the joint front corner of Lots 189 and 190 and running along the line of Lot 189 S. 54-55 W. 150 feet to an iron pin, joint rear corner of Lots 189 and 190; thence N. 35-05 W. 70 feet to an iron pin, joint rear corner of Lots 190 and 191; thence N. 54-55 E. 150 feet to an iron pin on West Dorchester Boulevard; thence along West Dorchester Boulevard S. 35-05 E. 70 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, Deed Book 511, at Page 513 and Deed Book 521 at Page 199.

The grantee is to pay 1956 taxes.
