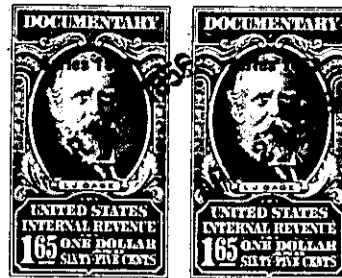
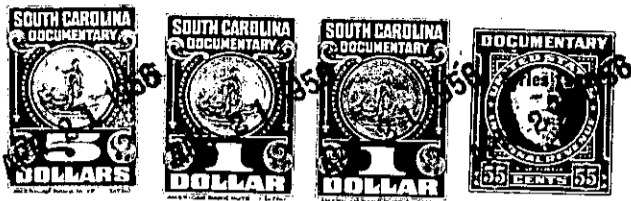

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina

Beginning at an iron pin on the northern side of White Circle, at joint corner of lots 4 and 5, and running thence N. 1/4 E. the line of lot no. 5 N. 8-25 W. 162 feet to an iron pin in line of lot No. 6: thence with the line of lot No. 6 N. 65 E. 80 feet to pin, corner of lots 4, 3, 6 and 8: thence with the rear line of lots 6 and 7 N. 23-40 W. 200 feet to an iron pin: thence N. 65 E. 205. 6 feet to iron pin: thence S. 23-40 E. 200 feet to pin: thence S. 20-20 E. 28. 8 feet to iron pin, rear corner of lot No. 1: thence with the rear line of lots Nos. 1 and 2 S. 71-40 W. 100 feet to iron pin, joint rear corner of lots 2 and 3: thence with the line of lot No. 2 S. 20-32 E. 245. 8 feet to iron pin on White Circle: thence with the Northern side of White Circle S. 87-27 W. 75 feet to end: thence continuing with White Circle N. 80-08 W. 132. 2 feet to the point of beginning.
