







Know All Men by These Presents:

That We, Dennis Skinner and Louise H.Skinner in consideration of the sum of Seven Thousand Five Hundred (\$7,500.00)

in the State aforesaid. DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Esley Kimbrell and Mildred B. Kimbrell and their heirs and assigns forever:

All of those two parcels or tracts of land in Oneal Township of Greenville County, S.C., lying on the South side of the Groce Meadow Road, bounded on the North by said road, on the East by C.W. Ballenger Estate lands, South by Beaver Dam Creek, and West by lands of grantors, having the following courses and distances: BEGINNING on a stake in the center of said road, joint corner of two-acre tract and Ballenger lands, and runs thence with said road N. 67 W. 208.7 feet to stake; thence S. 29.30 W. 418 feet to iron pin on edge of farm road; thence S. 17.15 W. 1661 feet, more or less, to stake on Beaver Dam Creek; thence down creek about S.70 E.332 feet, more or less, to a fence post, Ballenger corner; thence crossing creek and with old run of a branch N.26.49 W. to a persimmon on bank of branch; thence continuing up branch as follows: N.17.49 E. 88.5 feet, N.4.41 W. 204.8 feet, N.5.53 E. 504.5 feet, N.5.31 W. 224.5 feet to stake on west edge of the branch, and thence N.21 E. 112 feet to stake on west edge of the branch; thence N. 36 E. 290 feet to an iron pin in gully; thence N. 36.30 E. 34 feet to iron pin in gully; thence N. 29 E. 396 feet to the beginning corner, containing in the aggregate 11.40 acres, more or less. This land conveyed is made up of a two-acre tract as shown by record of deed to grantors in Deed Book 426, at page 439, in the R.M.C.Office for Greenville County, and a portion of tract conveyed to grantors shown by record of deed in Deed Book 514, page 86, in said R.M.C. Office.

It is understood and agreed by grantors and grantees that the farm road which runs through the above described tract and which continues through lands reserved by grantors shall remain open at all times, as it is now, for the purpose of ingress and egress to lands of grantors and grantees. This agreement shall be binding upon the grantors and grantees and their respective heirs, executors, administrators and assigns.
