presents do grant, bargain, sell and release unto the said
THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

ALL that piece, parcel or tract of land with all improvements thereon, situate, lying and being in Saluda Township, in Greenville County, State of South Carolina, containing 18 acres, more or less, located on the North side of U.S. Highway No. 25, and being known as Lot 2 on the plat of property of R. G.Ballenger, recorded in the RMC Office for Greenville County, S. C., in Flat Book "M", page 69, and having according to said plat the following description:

BEGITTING at a stake on the Morth side of Highway No. 25 at the corner of lots 1 and 2 and running thence F. 14-45 W., 1508 feet to a stone; thence N. 55-30 E. 500 feet to the center of the branch; thence following the meanderings of the branch as a line, 960 feet to the joint corner of Lots 2, 4 and 5; thence S. 64-30 E., 807 feet to a stake; thence S. 12-45 E., 229 feet, crossing the Will Creek to an iron pin on the North side of said Highway No. 25; thence in a Westerly direction following the right of way of said Highway as a line, 853 feet to the beginning point, less, however, the following tracks heretofore conveyed away:

The above described property originally containing 18 acres, and of trese 11.1 acres were subsequently conveyed away, leaving a remainder of 6.99 acres more or less, which is conveyed to the Grantee by this deed.
