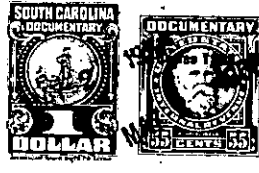

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CARLETON EDWARD BROWN, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 10 on Plat of North Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", pages 12-13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Neal Circle, joint front corner Lots 10 and 11, and running thence N. 68-26 E. 162 feet to an iron pin, joint rear corner Lots 10 and 11; thence N. 13-05 W. 125 feet to an iron pin; thence S. 79-10 W. 80 feet to an iron pin, joint rear corner Lots 9 and 10; thence S. 25-46 W. 140.1 feet to an iron pin on Neal Circle; thence around the curve of Neal Circle, the chord of which is as follows: S. 32-28 E. 25.6 feet and S. 10-50 E. 19.7 feet to an iron pin, the point of beginning.
