KING, ALEXANDER F. SCHENCK AND BEDA F. CALHOUN, AS TRUSTEES FOR LAURINDA C. SCHENCK, their successors and assigns forever, the remaining undivided one-third interest in and to the following:

M. Rea, et al, said Proceeding appearing of record in the office of the Clerk of the Superior Court for Henderson County, N. C. in Special Proceeding Minute Docket 9 at pages 395, et seq. and said Report of Commissioners and the Judgment confirming the same also appearing of record in the office of the Register of Deeds for Henderson County, N. C., in record of deeds 214 at Page 190, said first tract as herein described includes and comprises all of the eastern portion of the first tract as described in a deed of conveyance from Central Bank and Trust Company, Trustee, to Roland Hughes, and Union Trust Company of Detroit, dated July 12, 1929, and recorded in the office of the Register of Deeds for Henderson County, N.
