to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

ALL that piece, parcel or tract of land with all improvements thereon, situate, lying and being in Glassy Mountain Township, Greenville County, State of South Carolina, containing 58 acres, more or less, bounded by lands now or formerly of Mary Hipp, C. A. Gosnell, Joshua Gosnell, and S. C. Dickson, located on the branch waters of Brushy Creek and waters of the North fork of the Saluda River and having the following description:

BEGINNING at a chestnut oak 3x on the cliff and running nearly East to a black gum 3x; thence Northwest with Joshua Gosnell line to Brushy Creek to an ash 3x; thence with said creek to a poplar; thence nearly South to a poplar 3x; thence to a blazed chestnut 3x; thence to a blazed poplar; thence in the same direction to a hickory 3x and other parcel adjoining running thence nearly West, 41 poles or rods to a chestnut 3x; thence nearly South, 39 rods or poles to a hickory 3x; thence nearly East 22 rods or poles to a black oak 3x; thence nearly North, 28 rods or poles to the beginning corner.
