to incur in thus enforcing its rights as assignee of said lease and including any and all sums which may have been advanced by it for taxes, insurance, etcetera.

IT IS FURTHER AGREED that the undersigned shall not cancel said lease or consent to a surrender thereof or grant any modification or concession therein, nor consent to an assignment thereof without the written consent of The South Carolina National Bank of Charleston (The Belton, S. C. Branch), so lower as it holds a mortgage on the property above described.

Upon the full performance of the conditions and obligations of said note and mortgage hereinabove mentioned, this assignment shall be void and of no effect, and thereupon, in that event the said The South Carolina National Bank of Charleston (The Belton, S. C. Branch) will reassign to the undersigned its right, title and interest in and to the said lease so acquire under and by virtue of this assignment.
