to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Helen W. Henderson, her heirs and assigns forever, all that piece, parcel, or lot of land, with buildings, and improvements thereon, lying and being on the Westerly side of Robin Hood Road, near the City of Greenville, South Carolina, being shown as Lot No. 144 on a Plat of Sherwood Forest as recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "BB", pages 30 and 31, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Robin Hood Road, at a point 733 feet North of the Northwesterly corner of the intersection of Robin Hood Road and Forest Green Road, said pin being the joint front corner of Lots Nos. 143 and 144, and running thence along the Westerly side of Robin Hood Road, N. 8-05 E. 75 feet to an iron pin, joint front corner of Lots Nos. 144 and 145; thence along the joint line of Lots Nos. 144 and 145, N. 81-55 W. 197.6 feet to an iron pin in the center of a creek; thence S. 12-50 W. 75.26 feet to an iron pin, joint rear corner rear corner of Lots Nos. 143 and 144; thence along the joint line of said last mentioned lots S. 81-55 E. 203.8 feet to the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
