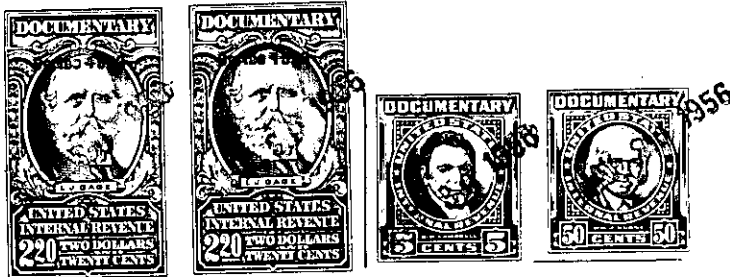

All those pieces, parcels or lots of land situate, lying and being in Chick Springs
Township, Greenville County, State of South Carolina, being known and designated as
Lots 13 and 14, Block "F", Mayfair Estates, as per plat thereof recorded in the R.M.C.
Office for Greenville County, South Carolina, in Plat Book "S", Pages 72 and 73; and
having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Tiffany Drive, joint front corner
Lots 14 and 15, and running thence N. 67-21 E. 204.6 feet to an iron pin, joint rear
corner Lots 14 and 15; thence N. 6-08 W. 50 feet to an iron pin, joint rear corner Lots
13 and 14; thence N. 23-09 W. 50.3 feet to an iron pin, joint rear corner Lots 12 and
13; thence S. 67-46 W. 219.3 feet to an iron pin on the Easterly side of Tiffany Drive,
joint front corner Lots 12 and 13; thence along the Easterly side of Tiffany Drive S.
23-09 E. 100 feet to an iron pin, the point of beginning.
