THOMAS D. CHRISTOPHER, his heirs and assigns, forever:

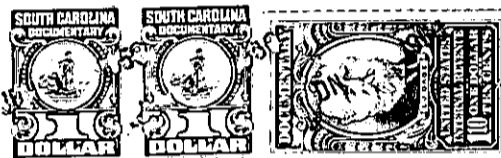
